- Rimrock/Green Gardens eventual transfer to County with likely reduction of some of gardened area (the back portion) unless accessory use to Conservation Zoning designation is amended to stand alone use as community garden (not presently in Fitchburg Zoning code). This will also require some footwork with ISNA as they have been helping to create more habitat (cleared the area for prairie that we use as garden) but allowing the garden on that portion as “interim”.
- Sheboygan = relocation imminent but location is still in process. If with State long term, might require a “fallback partner” for more permanency
